
Major Road Resurfacing, Intersection Improvements on Steeles Avenue East from Bayview Avenue to 280m East of Townsend Rd

Contract: 22ECS-TI-08MR
Start Date: September 4, 2023, End Date: November 24, 2024
*Timeline is subject to change.

The City of Toronto is planning to resurface Steeles Ave East from Bayview Ave to 280 m of Townsend Rd. Our inspection of the Steeles Ave East shows that it needs resurfacing, sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

In addition, the City is also planning to improve local geometric safety at the intersections. This work is in compliance with the accessibility for Ontarians with Disabilities act, of 2005 which mandates improvements in accessibility and safety for all road users, particularly for children, seniors and those with mobility challenges. This project is part of the Council-approved 2023 Capital Works Program to renew aging City roads, intersections and sidewalk for current and future needs.


MAP OF WORK AREA

MAP OF WORK AREA




WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark sidewalks and curbs requiring replacement and the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately two weeks before work begins with more information.
- The City will not be responsible for damage to any privately owned items on City property.



Accessible Accommodation: The City's contractor must ensure safe and accessible walkways and entryways are maintained for everyone during construction. Any temporary access disruptions will be communicated as soon as possible. If you experience a disruption, have a specific access need or related accommodation request, contact the **Project Manager** listed below.



Important information for owners of sprinkler systems / heated driveways and private landscaping features. Property owners should remove items located within City property limits (boulevard) to avoid damage.

This includes items such as landscaping (plants and pavers), decorative objects, sprinkler systems or heated driveways. If you have a sprinkler system or heated driveway, please contact the **Project Manager** listed below.
